
San Luis Valley Habitat Conservation Plan

Overview of Mitigation

Mitigation and monitoring of impact on riparian habitat resulting from activities covered by the Habitat Conservation Plan (HCP) are essential. To fulfill this obligation, the district collaborated with landowners to enroll mitigation sites on private lands through voluntary, cooperative agreements. These agreements enable the inclusion of a specific property in the HCP Mitigation Program, granting mitigation credits quantified in acres. These credits play a crucial role in counterbalancing all habitat impacts arising from covered activities within the San Luis Valley.

Land eligibility for enrollment in the mitigation program is contingent on the presence of high-quality riparian habitat and protection through a conservation easement, management agreement, or a similar mechanism ensuring habitat conservation. Participants in the mitigation program commit to maintain established land management practices and permitting routine habitat monitoring.
