I understand that upon the determination that this application is complete and confirmation of total payments to be made, this application will become a non-revocable offer to sell the above listed groundwater right(s) and/or groundwater permit(s) to the RGWCD.

I understand that the RGWCD is under no obligation to accept this or any other offer to sell groundwater right(s) and groundwater permit(s) and the acceptance or rejection of any offer is in the sole discretion of the RGWCD.

I understand that if the RGWCD accepts this offer, I will be required to sign a covenant that will prohibit any future irrigation of the above listed acres by groundwater, except for limited irrigation of lawn and gardens under an exempt well permit. I understand this covenant will be permanent and will apply to all future owners of these acres.

I understand that if the RGWCD accepts this offer, it will be contingent upon a showing of marketable title for the groundwater right(s) and/or groundwater permit(s) to the satisfaction of the RGWCD in its sole discretion. I also understand that I will cooperate with the RGWCD to execute additional documents or agreements necessary to complete the sale, including but not limited to a purchase and sale agreement, a dry-up covenant, a bargain and sale deed, and forms provided by the Colorado Division of Water Resources.
